

This modification obligates \$3,400,000.00 to the contract. Funds are to be allocated per the attached Distribution of Obligation Report. Total funds to date are changed from \$1,011,958,798.25 to \$1,015,358,798.25. Part I, Section B, Clause B-3, Obligation of Funds, paragraph a, is hereby changed as follows: "Pursuant to the clause FAR 52.232-22 (see Section I) entitled 'Limitation of Funds', total funds in the amount of \$1,015,358,798.25 (through modification A154) are obligated to the contract herewith and made available for payment of all allowable costs and fee to be incurred from the effective date of this contract through the period to end June 30, 2002."
