A. The purpose of this modification is to incrementally fund CLIN 02 of the contract in the amount of \$850,000.00. As a result of this modification, funds for CLIN 02 are hereby changed from \$9,113,504.36 to \$9,963,504.36. This funding is provided for continued Laboratory Operations supporting the Tank Farms Project. Notwithstanding Contract Clause I. 59, FAR 52.232-22, *Limitation of Funds (APR 1984)*, the Contractor shall notify the government when costs incurred reach 50 percent of allotted funds.
