


**Purpose of Modification:**

The purpose of this modification is to update Contract Section B, *Supplies or Services and Prices/Costs* as follows:

- Definitize Request for Equitable Adjustment (REA) 2012-010, *Craft Fiscal Year 2012 Wage Rate Adjustment*.

**Description of Modification:**

1. Contract Section B is revised to reflect the following negotiated settlement resulting from REA 2012-010:

Estimated Contract Cost (2012-010):	\$5,212,522
B& O Tax on Fee:	<u>\$0</u>
Total Estimated Contract Cost (TECC):	\$5,212,522
REA Settlement Fee:	<u>\$0</u>
Total Estimated Contract Price (TECP):	\$5,212,522

2. The table in Section B, *Supplies or Services and Prices/Costs*, Contract Section B.2 *Obligation and Availability of Funds and Contract Value*, paragraph (c) is deleted in its entirety and replaced with the following table, which incorporates the following revisions:

- Increase the Total Estimated Contract Cost (TECC) by \$5,212,522, from \$10,714,819,974 to \$10,720,032,496.
- Increase the Total Estimated Contract Price (TECP) by \$5,212,522, from \$11,309,943,514 to \$11,315,156,036.
- REA 2012-010 is non-fee bearing, therefore there is no change in Total Maximum Available Fee.
