**SF30 BLOCK 14 (CONTINUATION):**

- B. Change Order 290 authorizes CHPRC to re-evaluate and perform a statistical analysis of the data generated during the qualification testing of the Canister Storage Building stack (found in PNNL-12166). The purpose is to determine if stack flows rates outside of the range of those that existed during early testing (9050 to 9300 cfm) can be qualified as representative, and what that range would be. This evaluation and statistical analysis must include a specific evaluation of the range of operating flow rates, which are lower than the qualified range.
- C. The modeling and report, with evaluation and recommendations, shall be submitted to RL within 120 days after direction (November 20, 2015).
- D. The Contractor is hereby provided an immediate notice-to-proceed (NTP) with a not-to-exceed (NTE) authorized limit of \$30,000 prior to the definitization of the change order in accordance with Contract Clause I.102, FAR 52.243-2, Changes – Cost Reimbursement. The Contractor shall not exceed the NTE amount without prior approval from the Contracting Officer via a modification to increase the amount. The Contractor shall notify the Contracting Officer in writing with the rationale if the NTE amount is insufficient to proceed with the identified work.
- E. The definitization schedule due date for Change Order 290 is as follows:
