- B. An original Notice-to-Proceed with a Not-to-Exceed (NTE) amount of \$1,000,000 was authorized by Contract Modification No. 395, dated February 18, 2013. This modification (422) increases the NTE cost authority for Change Order No. 266 by \$1,000,000 for a total NTE authorized limit of \$2,000,000 prior to definitization in accordance with Contract Clause I.102, FAR 52.243-2, Changes – Cost Reimbursement. Contractor shall not exceed the NTE amounts provided herein without prior approval from the Contracting Officer via a modification to increase the amounts. Contractor shall notify the Contracting Officer in writing with the rationale if the NTE amounts are insufficient to proceed with the identified work.
- C. This modification does not add additional funds to the Contract. Accordingly, work under the Contract, such as that described herein, must be performed within the amount of funds which have been incrementally allotted to the Contract in accordance with Clause I.81, "FAR 52.232-22 Limitation of Funds (Apr 1984)."
