A. The purpose of this modification is to issue Change Order 302 "Initiate transition of River Corridor Contract (RCC) scope into the Plateau Remediation Contract (PRC)."

- B. CHPRC is authorized to prepare a Project Management Baseline for the RCC work scope transitioned to PRC.
- C. CHPRC is authorized to initiate remediation activities for waste site 300-296 with the Government furnished design provided by Washington Closure Hanford (WCH).
- D. CHPRC shall transition 300 Area Building no. 324 in accordance with PRC Section C, clauses C.2.3.14 and C.2.5.1 and C.2.5.4. Transfer building no. 324 no later than (NLT) March 31, 2016.
- E. CHPRC shall transition the Environmental Restoration Disposal Facility (ERDF) into the PRC in accordance with PRC Section C, clauses C.1.3, C.2.3, and C.2.3.14. Transition ERDF NLT July 31, 2016.
- F. CHPRC shall transition the 618-10 and 618-11 burial grounds into the PRC in accordance with PRC Section C, clause C.2.8. Transition the burial grounds NLT July 31, 2016.
- G. Transfer remaining RCC work, in accordance with Government approval NLT August 30, 2016.
- H. CHPRC is authorized to develop a change proposal for cost of transition, and cost of executing the identified work scope which is being transitioned into the PRC.
- I. The Contractor is hereby provided an immediate notice-to-proceed (NTP) with a not-to-exceed (NTE) authorized limit of \$2,000,000 prior to the definitization of Change Order 302 in accordance with Contract Clause I.102, FAR 52.243-2, Changes – Cost Reimbursement. Contractor shall provide monthly cost reports to the Contracting Officer (CO) and the Assistant Manager for River and Plateau (AMRP) to facilitate Government assessment of the need for additional funding and to ensure that cost is associated with the work defined herein. Contractor shall not exceed an NTE amount without prior approval from the CO via a modification to increase the NTE amount. Contractor shall inform the CO and AMRP in writing with its rationale prior to requesting an increase in the NTE.
- J. The work under the contract, described herein, must be performed within the amount of funds which have been incrementally allotted to the contract in accordance with Clause I.81 – FAR 52.232-22 – Limitation of Funds (Apr 1984).
