
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

This modification revises Modification 118, Assumption of the Public Safety and Resource Protection Programs as defined in the Statement of Work, Section C.2.1.8. The not-to-exceed amount of \$3,605,000 is increased by \$1,624,400 to a new amount of \$5,229,400. The revised paragraph will read:

MSA is limited in this task by a not-to-exceed amount of \$5,229,400 from funds allotted to this contract in accordance with Clause B.3, Obligation and Availability of Funds prior to the definitization of this change order in accordance with the referenced clause.
