This modification revises Modification 209, Stabilization of and improvements to the historic White Bluffs Bank facility. The not-to-exceed amount of \$100,000 is increased by \$125,000 to a new amount of \$225,000. The revised paragraph will read:

MSA is limited in this task by a not-to-exceed amount of \$225,000 from funds previously allotted to this contract in accordance with Clause B.3, Obligation and Availability of Funds prior to the definitization of this change order in accordance with the referenced clause.

MSA shall defer an equal value of B-Reactor upgrade activity and document the increase/deferral through their internal change control process. MSA shall maintain Continued ...
