**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

This Change Order directs MSA to begin implementation activities associated with moving the Public Safety and Resource Protection (PSRP) programs to the Mission Support Contract (MSC). MSA Letter MSA-1003636AR3 dated December 14, 2010 provides the implementation plan for moving the work scopes detailed in Section C.2.1.8 of the MSC from the Pacific Northwest National Laboratory to MSA. The contractor shall demonstrate to DOE its readiness to assume responsibility for the execution of the PSRP programs NLT March 28, 2011, and assume full responsibility for the PSRP programs on April 4, 2011 if all appropriate actions are completed to the satisfaction of DOE.

MSA is limited in this task by a not-to-exceed amount of \$700,000 from funds previously allotted to this contract in accordance with Clause B.3, Obligation and Availability of Continued ...
