

**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**

This modification concludes negotiations and definitizes the work scope for Curation that was directed via Change Order Modification 016 that added Section C, Clause C.2.1.8.7 Curation Services to the contract. This work scope is incrementally funded. The contract value of \$3,079,518,445 is increased by \$ 9,934,728 to a new contract value of \$3,089,453,173. The contract value detail for estimated costs and available fee are detailed in Attachment 1.

This modification corrects Mod 080 fixed fee value in Table B.4-2 from 7,231 to 7,230. Total contract value for Mod 080 is corrected to read \$3,059,507,224. Total contract value for Mod 076 is corrected to read \$3,079,518,445
