

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to authorize the Contractor to characterize and design remediation activities and/or develop a close-out package for the 300-277 waste site. The Contractor is hereby provided an immediate Notice-to-Proceed (NTP) with a Not-to-Exceed (NTE) authorized limit of \$150,000. Details of this contract change are included on Page 2 of this modification.
Period of Performance: 03/23/2005 to 09/30/2015

Except as provided herein, all terms and conditions of the document referenced in Item 9 A or 10A, as heretofore changed, remains unchanged and in full force and effect.

SF 30 BLOCK 14 CONTINUATION:

- B. This modification authorizes the Contractor to perform characterization and design activities for Waste Site 300-277, which is assumed to reside partially or wholly underneath the 300 Area North Container Transfer Area (CTA). Scope for geophysical and global positioning environmental radiological survey and ecological/cultural reviews under this change are limited to the area of the waste site outside of the CTA. Verification sampling is within the scope of this change, however, remediation activities are not. This work scope will be performed under Change Order No. WCH-CP-253 - 300-277 Waste Site Characterization and Design.
- C. As stated in paragraph A, above, this modification authorizes an NTP with an NTE authorized limit of \$150,000 prior to the definitization of Change Order No. WCH-CP-253 in accordance with Contract Clause I.70. Do not exceed the NTE amount provided herein without prior approval from the Contracting Officer via a modification to increase this amount. Notify the Contracting Officer in writing with your rationale if the NTE amount is insufficient to proceed with the identified work.
- D. This modification does not add additional funds to the contract. Accordingly, work under the contract, such as that described herein, must be performed within the amount of funds which have been incrementally allotted to the contract in accordance with Clause I.57, "FAR 52.232-22 Limitation of Funds (Apr 1984)."
- E. The definitization schedule for Change Order No. WCH-CP-253 is as follows:
