14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to issue Change Order 317 authorizing the Contractor to perform annual seed collection for purposes of securing seeds with a grower for planting and future harvesting for revegetation requirements at various locations within the Hanford Site. This change order also authorizes the Contractor to perform necessary transition activities for securing the vegetation for successful transition to a successor DOE Prime Contractor and incorporating into a transition plan submittal to DOE. The Contractor is hereby provided an immediate Notice-to-Proceed (NTP) with a Not-to-Exceed (NTE) authorized limit of \$14,000. Details of this Contract change are included on Page 2 of this modification.

- B. This modification authorizes the Contractor to perform seed collection in various areas at the Hanford Site and necessary transition activities for securing the vegetation. This work will be performed under Change Order No. WCH-CP-317 "Seed Collection for Future Vegetation Use."
- C. As stated in paragraph A, above, this modification authorizes an NTP with an NTE authorized limit of \$14,000 prior to the definitization of Change Order 317 in accordance with Contract Clause I.70. Contractor shall not exceed the NTE amount provided herein without prior approval from the Contracting Officer via a modification to increase this amount. The Contractor shall notify the Contracting Officer in writing with rationale if the NTE amount is insufficient to proceed with the identified work.
- D. This modification does not add additional funds to the contract. Accordingly, work under the contract, such as that is described herein, must be performed within the amount of funds which have been incrementally allotted to the contract in accordance with Clause I.57, "FAR 52.232-22 Limitation of Funds (Apr 1984)."
