Re: Freedom of Information Act Request

Dear Freedom of Information Act Officer:

I respectfully request, pursuant to the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, copies of the following documents:

1. Any and all documents in your possession, custody, and/or control, regarding the fence line along the Franklin County side of the Hanford Site.
2. Any and all documents in your possession, custody, and/or control, that you relied on in concluding that the fence line along the Franklin County side of the Hanford Site did not demarcate property ownership between the federal government and private land owners.

These documents should be releasable under FOIA. *See* 5 U.S.C. § 552(b). However, if you determine that any portion of these documents is exempt from release under FOIA, MSLF requests that you please cite the statutory provision that exempts the information from release and provide MSLF with all non-exempt portions of the request that can be reasonably segregated.

MSLF further requests that these documents be provided without charge or at a significantly reduced charge. MSLF is an Internal Revenue Code Section 501(c)(3) non-profit, public interest law firm dedicated to the defense and preservation of individual liberty, the right to own and use property, limited government, and the free enterprise system. Thus, MSLF cannot and will not realize any commercial benefit from receipt of these documents. Moreover, release of these documents will "likely contribute significantly to the public understanding of the operations or activities" of the BLM vis-à-

vis unpatented mining claims and the development of the Nation's resources. 5 U.S.C. § 552(a)(4)(A)(iii).

Finally, MSLF requests that these documents be provided within twenty (20) working days as required by FOIA. 5 U.S.C. § 552(a)(6)(A)(i).
