



VITRIFICATION PLANT OPERATIONS

Thank you for your November 12, 2002, letter regarding the future operation of the Hanford Site vitrification plant. Attached to your letter was a copy of sections of the Tank Waste Remediation System Privatization Contract between the U. S. Department of Energy (DOE) and British Nuclear Fuels, Limited, Contract No. DE-AC06-96RL13308 – Mod. No. A006, Part I, Section H. The DOE, Office of River Protection (ORP), did honor the terms and conditions of the referenced contract during its existence.

DOE terminated the contract referred to in your letter. The terminated acquisition strategy was replaced with a new contract instrument. A new contractor, Bechtel National, Inc. (BNI), was selected through competitive source selection. This new contract instrument was not considered a successor contract.

Your letter also referenced preferential hiring to Section 3161 of the National Defense Authorization Act for Fiscal Year 1993. Because this was not considered a successor contract, Preference in Hiring under Section 3161 was determined not to be applicable.

In reference to the construction of the facility, work is currently being performed under the Hanford Site Stabilization Agreement as agreed to between BNI and the Building and Construction Trades Department of the AFL-CIO, its affiliated International Unions and the Teamsters.

The role of Washington Group International, as part of the BNI team, is to provide an operations perspective to assist in the design, construction, and commissioning of the Waste Treatment and Immobilization Plant. In regard to your initial concern relating to the construction of a simulator training facility by BNI, ORP expects to discuss specific plans for plant operations, including the training of plant operations personnel, with BNI during the second half of 2003. The current plan is to require BNI to begin training in mid-2004 in preparation for cold commissioning operations, which are anticipated to start in mid-2005. Hot commissioning is not planned until 2007 at the earliest.
