FREEDOM OF INFORMATION ACT REQUEST (FOI 2016-01249)

This letter is in response to the request for information that you sent to the U.S. Department of Energy (DOE) Headquarters (HQ) Freedom of Information Act (FOIA) office. Your request has been forwarded to this office for response and was received on August 2, 2016. In that letter you requested a list of all workers, past and present, from all of the nuclear plants currently in operation or decommissioned that were employed by DOE or independent contractors in Washington, Oregon, Idaho, Montana, and Nevada. During a subsequent telephone conversation with me on August 3, 2016, you narrowed the scope of your request to include only a listing of the prime contractors that have contracted with DOE's Richland Operations Office (RL) and DOE's Office of River Protection (ORP) between January 1, 1990, and the present.
