The purpose of this modification is to obligate incremental funding in the amount of \$31,055,932.45 for Washington River Protection Solutions (WRPS) Base Funding, \$20,000,000 for Rocky Flats Administration, \$7,000,000 for Pension & Benefit Mound Administration, and \$1,890,600 for the Fiscal Year (FY) 2015 Low Activity Waste Pretreatment System (LAWPS). As a result of this modification, the total obligated funding amount is increased by \$58,946,532.45, from \$3,323,317,328.30 to \$3,382,263,860.75.
