

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the Not to Exceed (NTE) value for Washington River Protection Solutions LLC (WRPS) to continue work on the A and AX Retrieval Project in accordance with the Cost and Technical proposal submitted by WRPS in letter number WRPS-1400028 R2, REISSUE, dated May 13th, 2014. The current NTE value of \$24.9M, last updated in Modification 282 (14-CPM-0230, dated October 14, 2014), will support the scope of work for the A/AX project schedule through the middle of December 2014. Therefore, the NTE value is being increased by \$15M, for a revised total NTE value of \$39.9M to ensure that work will continue through the duration of the proposal negotiations.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL, 1984), WRPS shall continue to segregate costs associated with this Change Order in a separate charge Continued ...
