

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the Not to Exceed (NTE) value issued in Change Order modification 305 (15-CPM-0039, dated 02/12/15) for Washington River Protection Solutions LLC (WRPS) to continue work on the Effluent Treatment Facility (ETF) Transition Support in accordance with Clause I-103, Federal Acquisition Regulation (FAR) 52.243-2, Changes - Cost Reimbursement (AUG 1987). As a result of this modification, the current NTE value of \$600K is increased by \$600K, for a revised NTE value of \$1.2M. WRPS shall continue this work in accordance with the Statement of Work (SOW) provided in Attachment 1 of Change Order modification 305.
