The purpose of this modification is to increase the Not to Exceed (NTE) value issued in Change Order modification 309 (Letter number 15-CPM-0080) for Washington River Protection Solutions LLC (WRPS) to continue work on the implementation of the Office of River Protection (ORP) Tank Vapors Assessment Team (TVAT) recommendations. As a result of this modification, the current NTE value of \$5M is increased by \$19.7M, for a revised NTE value of \$24.7M. WRPS shall continue this work in accordance with the work scope provided in letter number 15-CPM-0034 (dated February 9th, 2015) to support completion of the Phase 1 activities that were defined as a result of the WRPS document titled Implementation Plan for Hanford Tank Vapor Assessment Report Recommendations.
