**Purpose of Modification:**

The purpose of this modification is to issue a change order to direct Bechtel National, Inc. (BNI) to proceed with the implementation of DOE Order (O) 232.2, *Occurrence Reporting and Processing of Operations Information*, Supplemental Contractor Requirements Document (SCRD). DOE O 232.2, SCR D, is hereby added to list of applicable directives in Contract Section J, *List of Attachments*, Attachment E, *List of Applicable Directives (List B-DEAR 970.5204.78)*, paragraph (b).

This SCR D is incorporated under the authority provided by Clause I.82, FAR 52.243-2 *Changes – Cost Reimbursement (AUG 1987) – Alternate III (APR 1984)*. This modification does not add additional funds to the contract. Accordingly, work under the contract for the change order must be performed within the amount of funds which have been incrementally allotted to the contract in accordance with Contract Clause B.2, *Obligation and Availability of Funds and Contract Value*, and Contract Clause I.66, *FAR 52.232-22 Limitation of Funds (Apr 1984)*. Additional direction provided to BNI in conjunction with this order is as follows:

- BNI shall submit within 30 (thirty) days of date of this modification a detailed technical and price proposal;
- A bi-lateral modification definitizing this change order shall be executed no later than 180 days after the date of this modification and receipt of an acceptable proposal; and
- BNI is not authorized any additional funds for the incorporation of the said SCR D.

This modification also incorporates revisions to Contract Section J, Attachment E, paragraph b. The changes included herein are as follows:

- Delete DOE Manual (M) 231.1-2, *Occurrence Reporting and Processing of Operations Information*, CRD;
- Delete Supplemental Contractor Requirements Document (SCR D) M 231.1, *Occurrence Reporting and Processing of Operations Information*, Revision 1;
- Delete HFID 232-1B, *Notification and Reporting of Operations Information*; and
- Add SCR D O 232.2, *Occurrence Reporting and Processing of Operations Information*, Revision 0.

As a result of these changes, Contract Section C, *Statement of Work*, Contract Clause C.6, *Standards*, and Contract Section H, *Special Contract Requirements*, Contract Clause H.24, *Emergency Clause*, are also revised accordingly. These revisions are incorporated under the authority of Contract Clause I.117, *DEAR 970.5204-78 Laws, Regulations, and DOE Directives (JUN 1997)*.

**Description of Modification:**

1. Update Contract Section C, *Statement of Work*, Contract Clause C.6, *Standards*, Standard 1, *Management Products and Controls*, paragraph (d), *Project Reporting*, sub-paragraph 5, *Occurrence Reporting*, and replace the reference to DOE M 231.1-2, *Occurrence Reporting and Processing of Operations Information*, with DOE O 232.2, *Occurrence Reporting and Processing of Operations Information*, SCRD. Contract Section C, Contract Clause C.6, Standard 1, paragraph (d), sub-paragraph 5 is replaced in full as follows:

(5) Occurrence Reporting: The Contractor shall adhere to DOE Order 232.2, *Occurrence Reporting and Processing of Operations Information*, Supplemental Contractor Requirements Documents (SCRD), with Hanford Site-specific requirements and methods for notification (Table C.5-1.1, Deliverable 1.8). The Contractor shall also adhere to the requirements of the ORP Supplemental (S) CRD to DOE Order 232.2 (256).

2. Update Contract Section C, *Statement of Work*, Contract Clause C.6, *Standards*, Standard 1, *Management Products and Controls*, paragraph (d), *Project Reporting*, sub-paragraph 6, *Environment, Safety, and Health Reporting*, and replace the reference to DOE M 231.1-2, *Occurrence Reporting and Processing of Operations Information*, with DOE O 232.2, *Occurrence Reporting and Processing of Operations Information*, SCRD. Contract Section C, Contract Clause C.6, Standard 1, paragraph (d), sub-paragraph 6 is replaced in full as follows:

(6) Environment, Safety, and Health Reporting: In addition to the *Occupational Safety and Health Act of 1970* and the *Price Anderson Amendments Act of 1988* (10 CFR 820) reporting requirements, the Contractor shall report all information specified in DOE Order 231.1A. The process and form of reporting will meet the requirements DOE Manual 231.1-1A, Change 2, *Environment, Safety and Health Reporting Manual*. The Contractor process will specify this requirement in contracts down to the lowest-tier subcontractor. The Contractor process will accumulate and provide a single report responding to requirement information for both the Contractor and all subcontractors (Table C.5-1.1, Deliverable 1.9). For occurrence reporting the Contractor shall adhere to the requirements of the Supplemental Contractor Requirements Document (SCRD) of DOE Order 232.2 (256).

3. Update Contract Section C, *Statement of Work*, Contract Clause C.6, *Standards*, Standard 4, *Construction, Procurement, and Acceptance Testing*, paragraph (j) and delete reference to HFID 232-1B, *Notification and Reporting of Operations Information*. Contract Section C, Contract Clause C.6, Standard 4, paragraph (j) is replaced in full as follows:

(j) Construction Emergency Response Plan: The Contractor shall develop and adhere to a Construction Emergency Response Plan that is compliant with the

applicable requirements of Hanford Emergency Management Plan, DOE/RL-94-02, and the emergency and fire prevention requirements of 29 CFR 1910 and 29 CFR 1926. (Table C.5-1.1, Deliverable 4.6) (215) (256).

4. Update Contract Section H, *Special Contract Requirements*, Contract Clause H.24, *Emergency Clause*, and delete paragraph (c), which references HFID 232-1B, *Notification and Reporting of Operations Information*. Contract Section H, Contract Clause H.24, paragraph (c), is revised as follows:

FROM:

- (c) The Contractor shall comply with the requirements of HFID 232.1B, *Notification and Reporting of Operations Information*, as it applies to reporting emergencies and abnormal events.

TO:

- (c) Deleted (256)

## **Supplemental Contractor Requirements Document (SCRD) 232.2 (Revision 0)**

**Title:** SCRD DOE Order 232.2, Occurrence Reporting and Processing of Operations Information

**Applicability:** Bechtel National, Inc. (BNI), Waste Treatment and Immobilization Plant (WTP)

The Contractor shall adhere to the responsibilities and requirements set forth in DOE Order 232.2 Section 5 *Responsibilities*, paragraph g, *Facility Manager*; Contractor Requirements Document (CRD), Attachment 1; and the Supplemental Requirements discussed below.

### **Clarifications:**

In addition to the notification requirements detailed in DOE O 232.2 CRD, DOE-WTP requires notification of all facility events including those not meeting the threshold of Occurrence Reporting. These notifications shall be timely and detailed enough to communicate the facts surrounding the event.

### **Supplemental Requirements:**

The DOE-WTP on-call Facility Representative (FR) shall be immediately notified (within 30-minutes) of the events described below; initial notification shall be by phone, with a detailed follow up email.

- **Fatality, either work-related or not**
- **Safeguards and security events** – comprising actions, inactions, or events that pose the most serious threats to national security interests and/or critical DOE assets, create serious security situations, or could result in deaths in the workforce or general public.
- **Offsite transportation incident or accident** – that results in, or has the potential to result in, harm to the environment or the public.
- **Any situation you believe warrants immediate notification**

Should BNI be unable to reach the DOE-WTP on-call FR, the pre-arranged assigned DOE-WTP manager shall be notified. The notification process must continue until someone has been contacted; use of voice messaging is not an acceptable method for notification.

Additionally, BNI management should notify the DOE-WTP on-call FR as soon as possible upon determining an adverse or abnormal event has occurred. Examples include non DOE O 232.2 reportable events such as: all first aid cases (via daily email), injuries, personal medical events; equipment damage/strikes, dropped objects, and any environmental issues; work-related personnel injuries that require treatment beyond first-aid (includes OSHA recordable injuries); chemical exposures; ambulance runs; event investigations (including critiques or fact finding sessions); work stoppages; and any other situation that might receive public, regulatory, or DOE Headquarter attention. Such contact is intended to allow the DOE-WTP FR to view the event scene prior to post-event changes, to observe the associated contractor actions, and to allow their attendance in any investigative meeting or critique.
