

**Purpose of Modification:**

The purpose of this modification is to update Contract Section B, *Supplies or Services and Prices/Costs*, and obligate \$60,000 in incremental funding under Purchase Requisition No. 13EM000206 for the Tank Farm Project (TFP).

**Description of Modification:**

1. The table in Section B, *Supplies or Services and Prices/Costs*, Contract Section B.2 *Ceiling Price*, paragraph (b) is revised as follows:

- The total obligated to the TFP Project under program code 1110909 is increased by \$60,000, from \$445,000 to \$505,000.
- The total funding obligated to the contract under CLIN 1 is increased by \$60,000 from \$9,737,323.06 to \$9,797,323.06
