14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to issue an increase to the Not-to-Exceed (NTE) value by \$1,800,000 for Washington River Protection Solutions LLC (WRPS) to continue work on the Effluent Test Facility Upgrades and Operations. As a result of this modification, the current NTE of \$18,000,000 is increased by \$1,800,000 for a revised NTE value of \$19,800,000.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APR 1984), WRPS shall continue to segregate and charge costs associated with the ETF Upgrades and Operations to a separate charge account until this work is definitized.

All other terms and conditions remain unchanged.
