14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the Not to Exceed (NTE) value issued in Change Order modification 314 for WRPS to continue work on the Effluent Treatment Facility Upgrades and Operations. As a result of this modification, the current NTE value of \$24,647,010 is increased by \$2.3M, for a revised NTE value of \$26,947,010. WRPS shall continue this work in accordance with the work scope provided in modification 316.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL, 1984), WRPS shall continue to segregate costs associated with the effort under the Effluent Treatment Facility Upgrades and Operations effort into the separate charge account created as a result of modification 316 until the change is definitized.
