
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)  
The purpose of this modification is to issue a Not-to-Exceed (NTE) value for Washington River Protection Solutions LLC (WRPS) to begin work on the 242-A Reboiler Replacement in accordance with ORP email from Wade Hader, Contracting Officer, dated March 17, 2016. As a result of this modification, the NTE value is \$500,000.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APR 1984), WRPS shall continue to segregate and charge costs associated with the 242-A Reboiler Replacement to a separate charge account until this work is definitized.

All other terms and conditions remain unchanged.
