

**14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)**  
The purpose of this modification is to issue an increase to the Not to Exceed (NTE) value by \$740,000 for Washington River Protection Solutions LLC (WRPS) to continue work on the Integrated Disposal Facility Performance Assessment (IDF PA). The NTE value of \$982,000 is being increased by \$740,000 for a total NTE of \$1,722,000.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (April, 1984), WRPS shall continue to segregate and charge costs associated with the Advanced Conceptual Design for the Low Activity Waste Pretreatment System (LAWPS) to separate charge account until this program is definitized.

All other terms and conditions remain unchanged.
