
The purpose of this modification is to issue an increase to the Not to Exceed (NTE) value by \$250,000 for Washington River Protection Solutions LLC (WRPS) to continue subcontractor renovation work on the 222-S Lab Room 1GB Upgrades. As a result of this modification, the current NTE of \$1,417,000 is increased by \$250,000, for a revised NTE value of \$1,667,000.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (April, 1984), WRPS shall continue to segregate and charge costs associated with the 222-S Lab Room 1GB Upgrades to separate charge account until this program is definitized.

All other terms and conditions remain unchanged.
