- A. This Modification adds the attached Special Bank Account Agreement Modification Number 4, which updates replacement page J-N-1, to contract Section J, Appendix N. (In Modification Number 4, the DOE exercises its option and extends the Special Bank Account Agreement through September 30, 2005.)
- B. This Modification also incorporates the attached Department of Labor (DOL) Wage Determinations as Attachment 11 to Section J, Appendix M. Appendix M is also updated with replacement pages J-M-1 and J-M-2, and new page J-M-13. DOL Wage Determinations are as follows:
1. The Department of Labor issued Wage Determinations 98-0109 (Revision 6) dated September 23, 2002, and 98-0109 (Revision 7) dated August 7, 2003. These two revisions were incorporated into the contract by modifications M168 and M190, respectively, and have not been updated. The period of applicability of Wage Determination 98-109 is as stated in the Collective Bargaining Agreements.
 2. Contract Modification M190 dated August 29, 2003, stated that Wage Determination 94-2569 (Revision 19) would be applicable from August 6, 2003 to August 6, 2004. During this period, the DOL increased the Service Contract Act health and welfare (H&W) single benefit rate. Effective June 1, 2004, the new SCA H&W single benefit rate became \$2.59 per hour, or \$103.60 per week, or \$448.93 per month.
 3. The DOL issued Wage Determination 94-2569 (Revision 22), to update Wage Determination 94-2569 (Revision 19). Determination 94-2569 (Revision 22) is applicable from August 6, 2004 to August 6, 2005.
 4. The DOL issued Wage Determination 94-2570 (Revision 16) to update Wage Determination 94-2570 (Revision 13). Wage Determination 94-2570 (Revision 16) is applicable from August 6, 2004 to August 6, 2004.
