OBLIGATION NOTICE NO. 55

A. The purpose of this modification is to increase the amount of funds obligated to this contract by \$29,313,954.75. See attached detail.

B. Part I - The schedule, Section B.2A., Obligation of Funds, is hereby increased by \$29,313,954.75. The first sentence of the paragraph is hereby changed to read as follows: "The amount presently obligated by the Government with respect to this contract is three billion, six hundred twenty-nine million, nine hundred eighteen thousand, eight hundred sixty-one dollars, ninety-two cents. (\$3,629,918,861.92)." Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as hereinbefore changed, remains unchanged and in full force and effect.


