A. The purpose of this modification is to increase the amount of funds obligated to this contract by \$45,055,226.90. See attached detail.

B. Part I - The schedule, Section B.2A., Obligation of Funds, is hereby increased by \$45,055,226.90. The first sentence of the paragraph is hereby changed to read as follows: "The amount presently obligated by the Government with respect to this contract is two billion, six hundred thirty two million, eight hundred eight thousand, seven hundred seventy two dollars, fifty seven cents. (\$2,632,808,772.57)."
