A. The purpose of this modification is to increase the Not-To-Exceed (NTE) cost authority for Change Order 305.

B. The previous Notice-to-Proceed with Not-to-Exceed (NTE) limit of \$2,000,000 was authorized by Contract Modifications No. 508, dated June 27, 2016. This modification increases the NTE cost authority for Change Order No. 304 by \$6,074,000 for a new total NTE authorized limit of \$8,074,000 prior to definitization in accordance with Contract Clause I.102, FAR 52.243-2, Changes - Cost Reimbursement. Contractor shall not exceed the NTE amounts provided herein without prior approval from the Contracting Officer via a modification to increase the amounts.
