- B. This modification authorizes the contractor to proceed with implementation of the requirements of DOE-0346, Revision 1A, Hanford Site Fall Protection Program. This NTP covers implementation only of DOE-0346, Revision 1A. Costs associated with development of the implementation schedule for DOE-0346, Revision 1A, were previously negotiated under Change Order No. WCH-CP-271, and incorporated into the Contract by Modification No. 539, dated June 11, 2014.
- C. As stated in Paragraph A, above, this modification authorizes an NTP with an NTE authorized limit of \$200,000 prior to the definitization of Change Order No. WCH-CP-259 in accordance with Contract Clause I.70.
