Modification Purpose:

The purpose of this modification is as follows:

1. Incorporate the change in award fee allocation between B.1 Project Management and B.2 Cost for the 2014-B Performance Evaluation and Measurement Plan (PEMP) evaluation period into Contract Section B, *Supplies or Services and Prices/Costs*.
2. Incorporate the 2014-B Rev. 0 PEMP into Contract Section B, *Supplies or Services and Prices/Costs*, by reference.

Modification Description:

1. The 2014-B PEMP re-allocates the available award fee for B.1 Project Management, from \$3,150,000 to \$3,780,000; and re-allocates the available award fee for B.2 Cost, from \$3,150,000 to \$2,520,000. The total available award fee for the 2014-B PEMP evaluation period remains unchanged at \$6,300,000. The available award fee allocated to 2014-B PEMP Award Fee Objective 1 (Critical Self-Analysis/Assessment/Discovery/Action), Award Fee Objective 2 (Environmental Safety and Health), and Award Fee Objective 3 (Quality Assurance Program) is considered B.1 Award Fee – Project Management Incentive in the amount of \$3,780,000; the available award fee allocated to Award Fee Objective 4 (Project Leadership/ Management (Cost, Schedule, and Scope on Project Performance)) and Award Fee Objective 5 (Technical Issue Resolution (Cost, Schedule, and Scope on Technical Issue Performance)) is considered B.2 Award Fee – Cost Incentive in the amount of \$2,520,000.
2. The 2014-B Rev.0 PEMP is hereby incorporated into Contract Section B, *Supplies or Services and Prices/Costs*, by reference.
3. As a result of the changes described in paragraphs one (1) and two (2) above, the tables in Contract Section B, *Supplies or Services and Prices/Costs* are revised as specified in paragraphs a through d below.
