



## BADGE REQUIREMENTS

## LACS CARD REQUIREMENTS

Citizenship verification required
Identity verification required
Second form of identification required

**First and Last names must match when more than one document is used to verify citizenship/identity\*\***

One of these highlighted forms of ID must be presented to validate citizenship.
One form of <b>photo</b> ID must be presented from <u>List A</u> to validate identity.
A second form of ID from <u>LIST A</u> or <u>LIST B</u> must be presented for LACS cards.

U.S. Passport ( <i>book or card</i> )	Certificate of U.S. Citizenship ( <i>Form N-560 or N-561</i> )
PIV Card ( <i>aka HSPD-12 badge</i> ) <ul style="list-style-type: none"> <li>Exempt from citizenship validation</li> </ul>	Certificate of Naturalization ( <i>Form N-550 or N-570</i> )
State issued driver license	Certification of Birth Abroad ( <i>Form FS-240 or FS-545</i> )
State issued Identification (ID) Card	Certification of Report of Birth issued by the Department of State ( <i>Form DS-1350</i> )
U.S. Military or U.S. Military Dependent ID Card	
ID Card issued by a U.S. government agency or entity including: <ul style="list-style-type: none"> <li>Transportation Worker ID Card</li> </ul>	Record of Military Processing ( <i>Form DD-1966</i> ) <ul style="list-style-type: none"> <li>Provided it reflects U.S. Citizenship</li> </ul>
	U.S. Citizen ID Card ( <i>Form I-197</i> )
	Federally recognized Tribal identification *** <ul style="list-style-type: none"> <li>Exempt from citizenship validation</li> </ul>
	U.S. Social Security Card
	Voter's registration card
	U.S. Coast Guard Merchant Mariner Card
	ID card issued by a federal, state, or local government agency or entity.

**\* All documents must be original or a certified copy and cannot be expired or cancelled.**

**\*\* A linking document must be used in the event the first and last names do not match (e.g., marriage certificate, divorce certificate, court order, etc.).**

**\*\*\* Federally recognized Tribal identification with a photo is exempt from citizenship and identity validation for paper visitor badges and paper building specific badges only.**
