

Revise Section H, Special Contract Requirements, clause H.55, PAID LEAVE UNDER SECTION 3610 OF THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES Act) to update the end date from December 11, 2020 to December 18, 2020 to implement legislation due to the Coronavirus pandemic.

Modification Description:

1. Clause H.55, PAID LEAVE UNDER SECTION 3610 OF THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT (CARES Act) is updated to revise the end date from December 11, 2020 to December 18, 2020 as follows:

H.55 Paid leave under Section 3610 of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) to maintain employees and subcontractors in a ready state. (482)(492)

- (a) The Contractor may submit for reimbursement and the Government (without requiring consideration but precluding additional fee) will treat as allowable (if otherwise allowable per federal regulations) the costs of paid leave (including sick leave) the Contractor or its subcontractors provide to keep employees in a ready state if--
 - (1) The employees: cannot perform work on a site approved by the Federal Government (including a federally-owned or leased facility or site) due to facilities closures or other restrictions; and cannot telework because their job duties cannot be performed remotely during the public health emergency declared on January 31, 2020 for COVID-19.
 - (2) The costs are incurred from March 27, 2020 through December 11, 2020.
 - (3) The costs do not reflect any amount exceeding an average of 40 hours per week for paid leave.
