Do not exceed the NTE amount provided herein without prior approval from the Contracting Officer via a modification to increase this amount. Notify the Contracting Officer in writing with your rationale if the NTE amount is insufficient to proceed with the identified work.
- C. This modification does not add additional funds to the contract. Accordingly, work under the contract, such as that described herein, must be performed within the amount of funds which have been incrementally allotted to the contract in accordance with Clause I.81, "FAR 52.232-22 Limitation of Funds (Apr 1984)." In addition, funds expended to implement this change order shall be from PBS 30.
