

B. The purpose of this modification is to document the supplemental agreement related to CHPRC Request for CP 030 293 1569, Revision 0.

C. As full equitable adjustment, the parties agree to the following cost and fee which is added to the contract under this modification:

Fee:	\$ 76,000
Total:	\$ 1,423,418

D. The above cost (\$1,347,418) and fee (\$76,000) are added to the contract. The fee of \$76,000 is authorized for draw down upon execution of this contract modification as a fixed fee settlement. Section B, Table B.4-1 is updated as follows:

Section B, Table B.4-1, Contract Cost and Contract Fee, is updated as follows:

- a. CLIN 3, Estimated Contract Cost: FY 2016 is increased from \$120,951,625 to \$122,299,043, and the Total Option Period is increased from \$529,316,774 to \$530,664,192.
- b. Total Option Period, Estimated Contract Cost: FY 2016 is increased from \$501,195,893 to \$502,543,311, and the Total Option Period is increased from \$2,168,875,808 to \$2,170,223,226.
- c. Total Option Period, Available Fee: FY 2016 is increased from \$21,094,386 to \$21,170,386, and the Total Option Period is increased from \$71,995,044 to \$72,071,044.
- d. Total Option Period, Contract Price: FY 2016 is increased from \$522,290,279 to \$523,713,697, and the Total Option Period is increased from \$2,240,870,852 to \$2,242,294,270.
- e. Total: Transition, Base & Option Periods, Total Contract Cost is increased from \$5,560,413,615 to \$5,561,761,033.
- f. Total: Transition, Base & Option Periods, Total Available Fee is increased from \$240,506,844 to \$240,582,844.
- g. Total: Transition, Base & Option Periods, Total Contract Price is increased from \$5,800,920,459 to \$5,802,343,877.
