The United States Department of Energy, Richland Operations Office (DOE-RL) has a need for a Third Party Administrator (TPA) for the Workers' Compensation Program (WCP) at the Department of Energy Hanford Site, located in Richland Washington.

This contract is subject to contract clause 52.232-18 Availability of Funds (Apr 1984). This is an administrative action to change incorrect accounting codes on CLINS 001, 005, 006, 009, and 012. This modification changes appropriated funds to non-appropriated funds on CLIN 005. This modification moves funds from CLIN 001 to CLIN 004. The total obligation for this contract remains \$810,000.00 which the Contractor exceeds at its own risk. The total amount of the contract without options remains \$1,619,421.14. The total amount of the contract with all options exercised remains \$4,345,531.38.
