

WCH submitted Change Order Proposal No. WCH-REA-206, Revision 0, "Incorporation of Contractor Requirements Document Order 436.1, Departmental Sustainability," on December 12, 2012 (CCN 169001). - B. A Notice to Proceed for Change Order No. WCH-REA-206 was authorized by Contract Modification No. 413, issued October 29, 2012. Modification No. 413 incorporated DOE CRD O 436.1, "Departmental Sustainability," as well as the related FAR and DEAR sustainability clauses, into the contract.
- C. As stated in paragraph A, this modification authorizes an NTE cost authority for WCH-REA-206 of \$66,568 prior to the definitization of Change Order No. WCH-REA-206 in accordance with Contract Clause I.70.
