### WCH PROVIDE FIELD PROJECT CORRDINATOR

### FOR NEW 300 AREA ELECTRICAL SERVICE

The Pacific Northwest National Laboratory (PNNL) in conjunction with the City of Richland (COR) is undertaking the installation of a new 300 Area electrical distribution service for PNNL and DOE owned facilities/buildings. PNNL is the project integrator for this effort. The COR is responsible for installation and distribution of the electrical service system within a DOE granted land easement. This action is consistent with various project agreements and DOE authorizations.

In pursuit of this action, PNNL is requesting that Washington Closure Hanford (WCH) provide a Field Project Coordinator to support the installation of the new electrical service. The Project Coordinator will interface with PNNL, the COR, WCH and Mission Support Alliance (MSA) on activities to help ensure an efficient, safe and successful installation.

Hence, we are requesting that an IWO is set up for WCH to provide the specified support in proceeding with the transition of the electric utility to the COR. We are expecting this new service to be complete by the end of CY 2013.
