The purpose of this modification is to issue a Notice to Proceed (NTP) with a Not-to-Exceed (NTE) limit for Change Order No. WCH-CP-319 "Supplemental Environmental Project Proposal for 100 B/C Borrow Pit 24 Restoration Enhancement." As stated in paragraph A, this modification issues the NTE cost authority for WCH-CP-319 in the amount of \$10,000 prior to the definitization of Change Order No. WCH-CP-319 in accordance with Contract Section I, Clause I.70. Contractor shall not exceed the NTE amount provided herein without prior approval from the Contracting Officer via a modification to increase this amount. Contractor shall notify the Contracting Officer in writing with your rationale if the NTE amount is insufficient to proceed with the identified work. This modification formalizes the advance e-mail authorization from Jenise Connerly to Scott Feaster on April 20, 2015 (effective date of this Contract modification 619).
