FREEDOM OF INFORMATION ACT REQUEST (FOI 2014-00223)

This letter is in response to your Freedom of Information Act (FOIA) request dated November 19, 2013. In that letter you requested information regarding Contract No. DE-AC27-01RV14800. Specifically, you requested the following information as stated below:

1. "Employer Compliance Agreement and Signature Sheet for Monarch Machine and Tool as governed by the Site Stabilization Agreement for All Construction Work for the U.S. Department of Energy at the Hanford Site (HSSA);
2. Certified payroll records for all off-site fabrication works performed by Monarch Machine and Tool at their Pasco facility;
3. Certified payroll records for all off-site fabrication works associated with the Remote Sampling Demonstration test platform."

In a letter dated November 20, 2013, you clarified your request and stated you were seeking documents regarding the Tank Operation Contract, Contract No. DE-AC27-08RV14800.

In your request you asked that you be notified with an assessment of fees for processing your request prior to fees being incurred. In our letter dated November 22, 2013, we indicated that your request will be placed on-hold until an estimate is done, you have been informed, and have agreed.

Your request was assigned to Washington River Protection Solution, LLC., (WRPS) the office that would most likely have responsive documents. A thorough search has been conducted and no documents were located. This search was conducted by those within the agency who are most familiar with the subject matter of your request, in locations where documents would most likely be found.

Since costs associated with your request fell under the \$15.00 threshold for charging fees under the FOIA, there will be no fees associated with this response.
