Public records dating from July 1, 2011 through February 22, 2012: Please send me public records summarizing discussions from any meetings (e.g., meeting minutes, meeting summaries, meeting notes, etc.) between the Washington State Department of Ecology (Ecology) and the U.S. Department of Energy (USDOE), where renewal of the Hanford Site Air Operating Permit (AOP) was discussed. 2. Public records dating from September 28, 2011 through February 22, 2012: Please send me the most recent schedule regarding issuance of the draft Hanford Site AOP renewal. [Draft permit means the version of a permit for which the permitting authority offers public participation or affected state review.' WAC 173-401-200 (10)] 3. Public records dating from July 1, 2011 through February 22, 2012: Please send me public records of periodic reports from USDOE Richland Operations Office staff to management (e.g., weekly reports, bi-weekly reports, monthly reports, etc.) in which renewal of the Hanford Site AOP is in any way referenced. Because the requested records already exist in electronic format, I am asking that the requested information be provided in electronic format. Please send it on a CD. I am also requesting a waiver of all fees for this request. Disclosure of the requested information is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the U.S. Department of Energy, Richland Operations Office; particularly with respect to coordinating regulation of air emissions from the Hanford Site.
