Re: Freedom of Information Act Request

This is a request for copies of records maintained by the United States Department of Energy (DOE) under the Freedom of Information Act. Specifically, I am requesting:

- Copies of contracts between the Department of Energy and Washington River Protection Services (WRPS) or Penser dating back to 2007 for services at the Hanford Nuclear Site.
- This request includes copies of the Department of Energy's procurement solicitation, the responses submitted by WSPR and Penser, any contract addenda, or documents pertaining to subcontracts issued under the primary agreements.

This request is being submitted by Hudson Munoz on behalf of an investigative reporter from Circa News. We ask that the Department of Energy provide expedited processing for this request as it is being made on behalf of Circa News, a news media organization primarily engaged in disseminating information. Additionally, the information sought concerns a matter of compelling need as responsive documents will inform public debate

during the 2016 presidential campaign.

Due to the time-sensitive nature of this request, we will hold the Department of Energy to a strict 20-day deadline for an initial response and expect the agency to provide written notice of its intention to take any extension to respond.

Please provide the specific FOIA exemption used to justify any redaction and an index of any documents withheld either in part or in its entirety as part of the agency's response.

We prefer to receive records in electronic format, and we are members of the news media for the purpose of fees. Please inform me if the cost of searching or copying these records will exceed \$100.
