FREEDOM OF INFORMATION ACT REQUEST (FOI 2017-01024)

This letter is in response to the Freedom of Information Act (FOIA) request you submitted to the U.S. Department of Energy (DOE) Headquarters FOIA Office on January 17, 2017. Your request was forwarded to this office to conduct a search for any responsive documents, and was received by this office on May 4, 2017. In your request you asked for “copies of all DOE classification training materials officials use to implement WPN-136.” In your request you stated “WPN-136 is a classification bulletin titled *Guidance on Release of Information Relating to the Potential for an Israeli Nuclear Capability*.”

Your request was assigned to the DOE Richland Operations Office (RL) Security & Emergency Services Division (SES) to conduct a search for any responsive documents. This search has been completed and no documents were located.

The undersigned individual is responsible for this determination. You have the right to appeal to the Office of Hearings and Appeals, as provided in 10 CFR 1004.8, for the adequacy of our search. Should you choose to exercise this right, your appeal must be filed within 90 days after receipt of this letter. You may submit your appeal by email to OHA.filings@hq.doe.gov, including the phrase “Freedom of Information Appeal” in the subject line. Should you choose to appeal, please provide my office with a copy of your appeal.

In addition, you requested a waiver of fees. As costs associated with your request were minimal, a determination on your request for a fee waiver is not being made.
