FREEDOM OF INFORMATION ACT REQUEST (FOI 2017-01366)

This letter is in reference to the Freedom of Information Act (FOIA) request you submitted electronically to this office. Your request was received in this office on July 5, 2017. In your request you asked for:

“all FOIA received by your agency between 1-January-2015 and the date this request is processed mentioning any of the words/codes below:

- Trump
- Tyson
- N757AF
- N725DT
- N76DT
- G-TRMP
- N76TE
- N99DU

For all of the aforementioned FOIA requests, I hereby request a description of the records requested and a copy of all responsive records that have been provided to the requesters. For the avoidance of doubt, I am requesting these records only for FOIA requests that have resulted in a full or partial grant. Requests that have been denied and those for which a disposition is pending are excluded.”

On July 5, 2017, a search for records was initiated and your request was assigned to the U.S. Department of Energy (DOE), Richland Operations Office (RL) Office of Communications and External Affairs to conduct a search for any responsive documents. The search has been completed and no documents were located. The search was conducted by a representative of the agency who is familiar with the subject areas of your request, in locations where responsive documents would most likely be found.

The undersigned individual is responsible for this determination. You have the right to appeal to the Office of Hearings and Appeals, as provided in 10 CFR 1004.8. Should you choose to exercise this right, your appeal must be filed within 90 days after receipt of this letter. You may submit your appeal by e-mail to OHA.filings@hq.doe.gov, including the phrase "Freedom of Information Appeal" in the subject line. Should you choose to appeal, please provide this office with a copy of your appeal e-mail or letter.

For the purposes of assessment of any fees, we have determined that your request falls within Section 1004.9(b)(4), ("all other requestors") of our FOIA regulations. See 10 C.F.R. 1004.9(b)(4). You are thus entitled to two (2) free hours of search time and 100 pages of duplication at no cost. However, as search costs fell under two (2) hours, you are being provided this response at no cost.
