The purpose of this modification is to increase the Not to Exceed value of \$200,000 from Change Order modification 187 (12-CPM-0153, dated 10/30/12) and modification 188 (12-CPM-0166, dated 11/02/12) for Washington River Protection Solutions (WRPS) LLC to participate on a Department of Energy (DOE) Office of River Protection (ORP) Team that will perform a Business Case Analysis of Direct Feed Low Activity Waste. This modification increases the current NTE of \$200,000 by \$73,000, for a total NTE value of \$273,000. This authorized work impacts Contract Line Item Number 3.1, Project Management, Section C.2.3.1, Planning Models. WRPS submitted their proposal November 7, 2012 (WRPS-1204750) and the proposal is currently being negotiated.
