14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
 The purpose of this modification is to increase the Not to Exceed (NTE) value of \$300,000 from Change Order modification 200 (13-CPM-0037, dated 03/06/13) for Washington River Protection Solutions (WRPS) to perform field testing of an alternative dome cutting technology and demonstrate that the technology can be successfully deployed. This modification increases the original NTE of \$300,000 by \$350,000, for a total of \$650,000. This authorized work impacts Contract Line Item Number 2.1, Single-Shell Tank Retrieval.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL 1984), WRPS shall continue to segregate and track costs associated with Change Order modification 200 to a separate charge account until the change is definitized.
