

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the current Not to Exceed (NTE) value of \$4.5M for Washington River Protection Solutions LLC (WRPS) to continue providing support for the U.S. Department of Energy (DOE), Office of River Protection (ORP), Low Activity Waste (LAW) System Design and Operability Review for the Waste Treatment and Immobilization Plant (WTP) and update the Statement of Work (SOW) provided in Modification 250 to include a Vulnerability Analysis and Recommendations Review with Bechtel National Incorporated (BNI), which is to be completed by September 30, 2014 with a draft report to be completed by November 21, 2014.

WRPS was authorized to begin the Design and Operability Review in Change Order Modification 250 (14-CPM-0039, dated 02/25/14) with an NTE of \$2.5M, based on a Rough Order of Magnitude Continued ...

	<p>of \$5M. The NTE was subsequently increased by \$2M, from \$2.5M to \$4.5M, in Modification 267 (14-CPM-0130, dated 05/30/14). As a result of this modification, the current NTE value of \$4.5M is increased by \$1.6M, for an updated total NTE value of \$6.1M. The \$1.6M increase is a result of an additional 34 Full Time Employees at \$150 per hour for 8 weeks.</p> <p>WRPS submitted a cost and technical proposal for the LAW System Design and Operability Review work scope on March 19, 2014 and a Technical Evaluation is currently in progress. In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL, 1984), WRPS shall continue to segregate costs associated with this Change Order in a separate charge account until the change is definitized. This Change Order will be definitized by September 30, 2014. The original and revised definitization schedules for this Change Order can be found in the Memorandum for Record in the Supporting Documents of this modification.
