14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to increase the Not to Exceed (NTE) value issued in Change Order modification 309 for WRPS to continue work on the implementation of the ORP TVAT (Tank Vapors Assessment Team) recommendations. As a result of this modification, the current NTE value of \$24.7M is increased by \$15M, for a revised NTE value of \$39.7M. WRPS shall continue this work in accordance with the work scope provided in letter number 15-CPM-0034 (dated February 9th, 2015) to support completion of the Phase 1 activities that were defined as a result of the WRPS document titled Implementation Plan for Hanford Tank Vapor Assessment Report Recommendations.

In accordance with Clause I-103A, FAR 52.243-6, Change Order Accounting (APRIL, 1984), WRPS shall continue to segregate costs associated with the TVAT recommendations into the Continued ...
