14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to issue a Not-to-Exceed (NTE) increase for Washington River Protection Solutions, LLC (WRPS) to continue working the Fiscal Year 2020 scope of work. The NTE is increased by \$58M, revising the NTE from \$141.5M to \$199.5M. Negotiations for the contract extension was completed December 19, 2019 and is expected to be definitized by January 31, 2020.
